Thank you very much for sending the report of the Congress which arrived in time to be translated. Lasala also received his copy and was present at the meeting of the Executive Committee.

In due course you will receive a full copy of the minutes of the meeting, but in the meantime I am sending you a report of the decision on the subscriptions of the Latin American Section.

The Committee decided that: "The subscriptions of Latin American members will be included in their entirety in the general budget of the FIAF, but this budget will include a Chapter called LATIN AMERICAN SECTION and covering expenses equal to half the sum of the subscriptions. In this way the unity of the FIAF budget will be respected in theory.

"An additional budget for the year 1955-1956 will be established by the International Secretariat covering the sums allotted to the Latin American Section. This amended budget will be submitted to the General Assembly for approval, ~~subject to the reductions accorded to the Cinemateca Uruguay and the Cinemateca Argentina by the last General Assembly will also require revision as a result of this decision, the subscriptions of these two archives being re-established at Fr 120.000 for 1955-1956, half of this sum being allotted to the Latin American Section.~~

~~The Executive Committee will allocate half the subscription of the Filmoteca de Suiza a la Sección de América Latina. The question of the subscription of the Cinemateca de Uruguay will be examined at the Congress.~~

I think this will solve the problem of the subscriptions for you, and the decision will apply for the subscriptions owed by the Latin American members for this year 1955-1956. The sums we received during this year were, as you know, owing on 1954-1955.

As I am going on holiday from the beginning of August until the Congress early in September, I must complete all preparations before I leave. This includes the amended Budget for 1955-1956 for which I will require your details for the Latin American chapter. No doubt it will be necessary at the moment to draw up a projected
